At age 17, Hutchinson native Colby Smith experienced a car accident that left him with a fractured neck and a paralyzing spinal cord injury. Plunged into a new world, and despite physical challenges and financial stresses, Colby committed to continuing to live life on his own terms. By age 35, he had earned his master's degree in vocational rehabilitation counseling. With a diligent pursuit of rehabilitation, on July 13, 2017, Colby took his first steps in 18 years.

Today, Colby is fundraising with the nonprofit Help Hope Live to secure a much-needed source of mobility and independence: an accessible vehicle. Such a vehicle costs \$30,000 out-of-pocket: insurance offers no assistance or coverage for this critical component of Colby's daily life.

So far, he has raised \$1,500 towards his first \$10,000 fundraising milestone.

Colby's dream is to pay it forward once his own needs are met, assisting other spinal cord injury survivors with their journeys to greater independence and mobility.

"After 22 years of living with paralysis, I have learned that it is okay to not be okay," Colby explained. "I believe that life isn't about having or regaining the ability to walk. It's about mastering the art of transforming our disadvantages into advantages." That concept is the inspiration for the book Colby is currently writing about his life experiences.

Golf tournament registrations and all other donations made to Help Hope Live in honor of Colby are tax deductible to the extent allowed by law, and all funds raised will be managed by the nonprofit to cover verified medical and related expenses. Help Hope Live verifies medical and financial need for every patient.

Since 1983, campaigns organized by Help Hope Live have raised over \$150 million to pay patient expenses.
